Detailed regulations concerning completing a study program, getting credits for each year of the studies, and sequential system of courses and exams in the medical program of the Faculty of Medicine, Jagiellonian University Medical College in the academic year 2017/18

Students of the Faculty of Medicine, Jagiellonian University Medical College are subject to the general regulations included in the JU Study Rules and Regulations.

The herein presented detailed regulations concerning completing a study program and a study year, as well as sequential system of courses and exams in the medical program of the Faculty of Medicine are part of study plan at the Faculty of Medicine, Jagiellonian University Medical College in the academic year 2017/18.

Regulations concerning completing a study program and obtaining promotion to consecutive year of studies.

- 1. To complete a study program required are: acquisition of credits and passing of final exams in all obligatory courses and one facultative course per year (if included in the study program), and obtaining credits for all summer clerkships included in the study program.
- 2. To complete a study year and obtain promotion to the consecutive year of studies required are: acquisition of credits and passing of final exams in all courses carried out in the given academic year, including at least one elective course (applies to the study years comprising elective courses), obtaining credit for summer clerkship scheduled for the given year, and obtaining minimum of *(find below minimal no. of ECTS points in the case of SMO) ECTS points for the given year
- 3. For conditional promotion to the consecutive study year required are: acquisition of *(in the case of SME find below) ECTS points for the given study year and passing of final exams in the flag courses of the given study year.
- 4. The flag courses comprise: anatomy, pathology and pharmacology.
- 5. Repeating a course is tantamount to the necessity of partaking in all classes, tests and exams in the given course anew. Exemptions from participation in classes and retaking tests may be granted by the Course Coordinator. In the case of courses carried out in segments over consecutive study years, required is repeating only of the segment which has been failed.

Sequential system of courses and examinations.

- 6. Passing final exams in the flag courses is prerequisite for undertaking any courses included in the study program of the consecutive study year. Exceptions can be made with the Dean's consent and participation in courses of the consecutive study year allowed. It pertains only to facultative courses, and non-clinical courses that do not conclude with a final exam.
- 7. Undertaking any of the 6th year /M-4 year courses is conditional on completion of all flag courses, and **ALL** courses carried out in segments over consecutive study years and continued in the 6th year/M-4 year. Exceptions may be allowed for, and student admitted to participation in 6th/M-4 year courses despite lack of credit or passing grade in another 5th year/M-3 year course (i.e. nor a flag course or a course carried out in segments), on the condition that retaking the course will not interfere with following the 6th year/M-4 year curriculum (required is an approval from the course coordinator of the course being repeated).
- 8. Regarding courses carried out in segments over consecutive study years, the possibility of sitting for credit/final exam in a subsequent segment of a subject before obtaining credit/ passing an exam in the preceding segment is determined by the course coordinator, except for the 6th year/M-4), to which point no.7 pertains. Information regarding that matter is published in School website before the start of classes in a given academic year.
