In response to the suspension of the Step 2 Clinical Skills (CS) exam by the United States Medical Licensing Examination® (USMLE®) program, the Educational Commission for Foreign Medical Graduates (ECFMG®) has established new pathways that will allow qualified medical students and graduates to meet the clinical skills requirement for ECFMG Certification. These pathways are intended only for individuals who, among other requirements:

- do not have a passing performance on USMLE Step 2 CS that is valid for ECFMG Certification, and
- are not certified by ECFMG, and
- plan to enter a U.S. program of graduate medical education (GME) in 2021.

Detailed information on the pathways is available on the ECFMG website.

The eligibility requirements for <u>Pathways 3, 4, and 5</u> require that the applicant's medical school attest to the applicant's clinical skills by completing an <u>ECFMG Clinical Skills Attestation form</u> and submitting it to ECFMG no later than January 31, 2021. Full instructions are available on the form.

As part of the attestation, applicants must have their clinical skills assessed by appropriate medical school faculty during three clinical patient encounters lasting 10 to 20 minutes each. At least one of the encounters must be on the general medical hospital service. Each patient should be new to the applicant, and each encounter must be observed directly by a different faculty member who routinely evaluates medical students. The observed encounters must take place at the applicant's medical school or affiliated clinical rotation site.

The following Mini-CEX form may be used by the observing medical school faculty to assess these clinical encounters.

If the applicant's medical school or affiliated clinical rotation site already uses a form for the evaluation of clinical encounters with the same clinical skills as those outlined on the following Mini-CEX form, the institution's form may be used in place of the Mini-CEX form.

For applicants whose clinical rotations are already complete, patient encounters that were evaluated previously are acceptable, provided they were assessed using the same skills as those outlined on the following Mini-CEX form.

Instructions

A Mini-CEX form should be completed for each clinical encounter. The observing faculty member should provide all information requested on the form and assess the applicant's performance in each skill listed using the numerical scale provided. The faculty member should also indicate any areas in which the applicant performed especially well and any areas in which the applicant needs improvement.

Each completed Mini-CEX form should be signed by both the applicant and the observing faculty member and submitted to the dean of the medical school, or a designee of the dean, for review. The dean, or the dean's designee, must review the completed Mini-CEX forms and confirm that they indicate a satisfactory level of clinical skills.

An authorized school official must then complete the <u>ECFMG Clinical Skills Attestation form</u> and submit it to ECFMG following the instructions on the Clinical Skills Attestation form. The Mini-CEX forms should not be submitted to ECFMG.
